This terms (together with the documents referred to therein) ("**Online User T&C's**") tell the buyer (you) the terms and conditions on which Aston Barclay Limited provides facilities for you to place online bids (**Bids**), using Aston Barclay LIVE and Bid Now and to make an online offer (**Offer**), using Aston Barclay Buy Now for a vehicle (**Vehicle**) which is listed on our website www.astonbarclay.net (**our site**) and which is available at one of the auction centres.

Please read these terms and conditions carefully before placing any Bids or making any Offers through our site. You should understand that by logging in to use our site, you agree to be bound by these Online User T&C's and you acknowledge that they override any terms and conditions which you purport to impose.

Any Bids or Offers placed by you, and any contract for the purchase of a Vehicle, is made in accordance with and subject to these Online User T&C's and the [General Conditions of Auction](#). These Online User T&C's should be read in conjunction with the General Conditions of Auction. In the case of conflict or inconsistencies between these Online User T&C's and the Auctioneer's [General Conditions of Auction](#), these Online User T&C's shall prevail, to the extent of such conflict or inconsistency. When using the online facilities, the [General Conditions of Auction](#) shall be treated as varied by the Online User T&C's by the insertion of conditions 1 to 14 inclusive of these Online User T&C's.

Use of our site is governed by these Online User T&C's and the [Website Terms of Use](#). These Online User T&C's should be read in conjunction with the [Website Terms of Use](#). In the case of conflict or inconsistencies between these Online User T&C's and the [Website Terms of Use](#), the [Website Terms of Use](#) shall prevail, to the extent of such conflict or inconsistency.

1 Information About Us and our auction centres.

1.1 www.astonbarclay.net is a site operated by Aston Barclay Limited (we/us). We are registered in England and Wales under company number 01644813 and our registered office address is *Form 2, 18 Bartley Wood Business Park, Bartley Way, Hook, Hampshire, England, RG27 9XA*

1.2 We have four divisions operating from the following auction centres:

- 1.2.1 Aston Barclay Chelmsford trading at The Car Auction, Drovers Way, Chelmsford, Essex, CM2 5PP;
- 1.2.2 Aston Barclay Wakefield trading at Units 1& 2 Harvard Way,, Normanton, West Yorkshire, WF6 1FL;
- 1.2.3 Aston Barclay Prees Heath trading at Heath Road, Whitchurch, Shropshire, SY13 2AE;
- 1.2.4 Aston Barclay Donington Park, trading at Donington Park, Castle Donington, Derby, DE74 2RP;
- 1.2.5 Aston Barclay Westbury trading at Brook Lane, Westbury, Wiltshire, BA13 4EN.

1.3 When you place a Bid or make an Offer, you are placing it with the relevant centre which is running the auction in question, depending on the location of the Vehicle. In each case, the relevant centre will be the auctioneer (**Auctioneer**).

2 Service Availability

2.1 Your use of our site is subject at all times to our [Terms of Website Use](#) and our [Privacy Policy](#). By logging into our site, you agree to comply with our [Terms of Website Use](#) and accept your personal data will be processed in accordance with our [Privacy Policy](#).

2.2 Your attention is drawn to section 7 of the Terms of Website Use which apply to any Offer and Bids made through our site. We do not guarantee that your access to our site or that your placing of Bids or making of an Offer will be uninterrupted, without delay, secure or error free. Our site is provided on an "as is" basis and, to the extent permitted in law, we exclude all liability whatsoever arising out of or in connection with your inability to access our site, place Bids or win any auctions.

3 Your Status

3.1 By logging into our site and placing a Bid or making an Offer, you warrant that:

- 3.1.1 You are the registered user of the username and password which was allocated to you on the opening of your account to use our site;
- 3.1.2 You are placing a Bid or making an Offer on behalf of a business acting in the course of business;



- 3.1.3 You are authorised to place Bids or make an Offer on behalf of the business and to legally bind that business; and
- 3.1.4 You are at least 18 years old.

4 How the Contract Is Formed Between You and the Seller

4.1 Once you have placed a Bid or made an Offer, our online system will indicate whether it has been registered. Your Bid or Offer constitutes an offer to the Auctioneer (as agent of the third party seller (Seller)) to buy a Vehicle. If your offer is accepted by the Auctioneer on behalf of the Seller and the reserve price has been met, confirmation of such acceptance (**Bid or Offer Acceptance**) will be highlighted on the online screen, by email or by notification on the website.

4.2 You may not withdraw any Bids or Offers without the Auctioneer's consent.

4.3 If our system confirms your Bid or Offer has been accepted in accordance with condition 4.1 above, you will become the “Buyer” as defined in the Auctioneer’s [General Conditions of Auction](#) and accordingly the following sections of [General Conditions of Auction](#) shall apply:

- 4.3.1 Part B (Conditions of the Contract of Sale between the Seller and the Buyer);
- 4.3.2 Part C (Terms as between the Auctioneer and the Buyer) of the Auctioneer’s;
- 4.3.3 Part E (Terms and Conditions of Taxi and Salvage Checks for Buyers); and
- 4.3.4 Part G (General Terms Applicable to all Parts of these Conditions);

4.4 All online sales of Vehicles shall be treated as sales effected by the fall of the hammer in the auction hall and not as private treaty sales. A private treaty sale is:

- 4.4.1 one concluded following an unsuccessful auction where the seller is informed of the highest bid and we provide facilities and services which the seller may utilise to make a contract for the sale of the Vehicle to the highest bidder or another interested party; or
- 4.4.2 any other sale of a Vehicle which is agreed as a direct result of the auction process but not a sale effected by the fall of the hammer during the auction (physically or online).

5 Delivery

You should note that it is your responsibility to arrange collection of the Vehicles you have bought. The Auctioneer may at its discretion offer delivery services in respect of the Vehicle, but this will be subject to transporter and driver availability, additional

charge and the Auctioneer's Conditions of Delivery, which are available upon request from the Auctioneer.

6 Payment of Online Auction Fee

In addition to any charges fees or purchase monies payable under the Auctioneer's [General Conditions of Auction](#), you will be liable to a fee of £34 plus VAT charged by us for participating in and (if applicable) winning the relevant auction through using our site. Details of our current fees, and those of the Auctioneer, can be obtained from the Auctioneer prior to the auction. The fee for participating in the auction and (if applicable) for winning the auction through using our site will become due for payment upon generation of the Bid or Offer Acceptance (see condition 4.1) and must be paid to the relevant Auctioneer at the same time as you pay for the Vehicle as provided for by the Auctioneer's [General Conditions of Auction](#).

7 Our Liability and the Auctioneer's Liability

7.1 The Auctioneer's liability to you in respect of any Vehicle sold at auction is as set out in the Auctioneer's [General Conditions of Auction](#), as is the Seller's liability.

7.2 Our liability to you in respect of the operation of our site is as set out in our [Website Terms of Use](#).

7.3 You accept that your purchase of the Vehicle is being made in accordance with the Auctioneer's [General Conditions of Auction](#). You acknowledge and confirm we have no liability or obligation whatsoever to you in respect of any representation or statement made by us on our site about the specification, colour or condition (together "details") of the Vehicles listed there. All such details are provided for information purposes only. All Vehicles are available for inspection prior to commencement of the auction and you should satisfy yourself as to the details of the relevant Vehicle prior to placing any Bids or making an Offer.

7.4 Nothing in these terms and conditions limits in any way our liability for death or personal injury caused by our negligence or for fraud or fraudulent misrepresentation or for any other liability that cannot be excluded in law.

8 Written Communications

Applicable laws require that some of the information or communications we send to you should be in writing. When using our site, you accept that communication with us (and the Auctioneer) will be mainly electronic. We (and/or the Auctioneer) will contact you by email or provide you with information by posting notices on our website. For contractual purposes, you agree to this electronic means of communication and you acknowledge that all contracts, notices, information and other communications that we



provide to you electronically comply with any legal requirement that such communications be in writing.

9 Notices

All e-mail notices given by us (and the Auctioneer) to you will be sent to you at the e-mail address you provided to us when registering to use our site. Notices under these Online User T&C's will be deemed received and properly served immediately when posted on our website or 24 hours after an e-mail is sent. In proving the service of any notice, it will be sufficient to prove, in the case of an email, that such email was sent to the e-mail address specified by you when you registered to use our site, or in the case of notices posted on our site, by the production of a copy of the cached page showing the notice.

10 Waiver

- 10.1 If we fail, at any time, to insist upon strict performance of any of your obligations under any of these Online User T&C's, or if we fail to exercise any of the rights or remedies to which we are entitled under these Online User T&C's this shall not constitute a waiver of such rights or remedies and shall not relieve you from compliance with such obligations.
- 10.2 A waiver by us of any default shall not constitute a waiver of any subsequent default.
- 10.3 No waiver by us of any of these Online User T&C's shall be effective unless it is expressly stated to be a waiver and is communicated to you in writing in accordance with condition 8 above.

11 Severability

If any of these Online User T&C's are determined by any competent authority to be invalid, unlawful or unenforceable to any extent, such term, condition or provision will to that extent be severed from the remaining terms, conditions and provisions which will continue to be valid to the fullest extent permitted by law.

12 Entire Agreement

- 12.1 These Online User T&C's, together with the General Conditions of Auction, Website Terms of Use, Privacy Policy and (where applicable) the Auctioneer's Conditions of Delivery represent the entire agreement between us in relation to the subject matter contemplated by these Online User T&C's and supersede any prior agreement, understanding or arrangement between us, whether oral or in writing.



12.2 Neither of us shall have any remedy in respect of any untrue statement made by the other, whether orally or in writing, prior to the date of a contract being formed between us on these Online User T&C's (unless such untrue statement was made fraudulently or liability cannot be otherwise excluded or limited in law).

13 Our Right to Vary These Terms and Conditions

13.1 We have the right to revise and amend these Online User T&C's from time to time.

13.2 You will be subject to the policies and Online User T&C's in force at the time that you log in to use our site.

14 Law and Jurisdiction

Your use of our site and contracts for the purchase of Vehicles entered into through our site and any dispute or claim arising out of or in connection with them or their subject matter or formation (including non-contractual disputes or claims) will be governed by English law. Any dispute or claim arising out of or in connection with such contracts or their formation (including non-contractual disputes or claims) shall be subject to the exclusive jurisdiction of the courts of England and Wales.
